**Release and Waiver of Liability (participant)**

There are risks, both known and unknown, involved when using any inflatable or amusement device, including, but not limited to, physical injury, emotional injury, distress, paralysis, and even death. The risk of serious injury from participating inflatable activities, although minimal, does exist, as it does in all play and amusement activities.

- Each participant must have a liability waiver submitted on his/her behalf.
  - Shirt/Shoes must be worn at all times while using the Bubble ball inflatables
  - No sharp objects may be worn or carried. Please remove any objects, including jewelry that might puncture the Bubble ball inflatables.
  - Bubble ball inflatables are not meant to protect from a fall
  - No jumping off ledges, tables, etc., is allowed, as injury can occur.
  - It is recommended to play with like ages and body sizes while using Bubble ball inflatables
  - No food, candy, or drinks are allowed within the Bubble ball inflatables.
- No one under the influence of alcohol or any other substance will be allowed to participate in the event provided by Golf Indigo who has every right to use their best judgment when determining if the participant is under the influence or fit to play.

**Release/Waiver**

Its consultants and others who those authorized to give recommendations, directions, or instructions, to engage in risk evaluation or loss control activities regarding Golf Indigo events held at such facility and each of them, their directors, officers, agents, staff, volunteers, all for the purposes herein referred to as "Release"...FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next to kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT (S) ARE DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
